BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF FORT SCOTT, BOURBON COUNTY, KANSAS:


ORDINANCE 2740 SECTION 10.48.030 is amended as follows:

Penalty for Violation


The penalty for violation of this chapter is minimum fine of One Hundred Twenty-five Dollars (\$125.00) up to and including a maximum fine of Five Hundred Dollars (\$500.00) per violation plus applicable court costs.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF FORT SCOTT, BOURBON COUNTY, KANSAS:

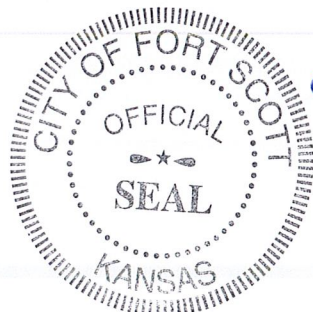
ORDINANCE 2787 SECTION 10.48.020 is amended as follows:

Routes designated.


The following streets have been designated as truck routes for the city:


- A. U.S. 69 Bypass extending from the north city limits to the south city limits;
- B. U.S. 54 commencing at the north city limits to the east city limits by way the Wall Street U.S. 69 Bypass exchange;
- C. Third Street west from U.S. 69 Bypass to State Street;
- D. State Street north from the intersection of Third and State Streets to the intersection of Wall and State Streets;
- E. Wall Street east from the intersection of State Street and Wall Street to U.S. 69 Bypass;
- F. Humbolt Avenue (Maple Road) as it runs east from the west city limits to the intersection of National Ave;
- G. Linker Street as it runs from the intersection of Crawford and Linker Street to National Ave.
- H. National Ave as it runs from the intersection of Humbolt Avenue/Market Street and National Ave. north to the city limits;
- I. Cooper Street from 23rd Street to 20th Street;
- J. 23rd Street from U.S. 69 Bypass to Liberty Bell Road;
- K. Liberty Bell Road from 23rd Street to Campbell on to Hudson Street to 69 Highway;
- L. 20th Street from U.S. 69 Bypass to Cooper Street;

ORDINANCE NO. 3623

AN ORDINANCE AMENDING 2740 SECTION 10.48.010, FORT SCOTT MUNICIPAL CODE DEALING WITH VEHICLES REQUIRED TO FOLLOW TRUCK ROUTE OF THE CITY OF FORT SCOTT, BOURBON COUNTY, KANSAS.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF FORT SCOTT, BOURBON COUNTY, KANSAS:

ORDINANCE 2740 SECTION 10.48.010 is amended as follows:

Vehicles required to follow truck route.


From and after the designation and signing of any truck route in the city:

A. To pick up or deliver cargo, such vehicle may depart from the truck route(s) by the shortest distance to end from the point of said pickup or delivery. In the case of multiple pickups or deliveries, said departure shall take a route which has the shortest cumulative distance not on the truck route(s).

B. Every truck tractor, trailer (with or without trailer or semi-trailer) and every vehicle or trailer having three or more axels shall use and follow such prescribed route or routes while in the city and shall not use any residential street or other street except those designated and marked as truck routes.


Officers of public safety of the city may direct the rerouting of all such vehicles at their option.
