Key Findings from Survey

Key Finding #3

When asked if individuals with disabilities in Uniontown can access everything needed to live a full, healthy life, only 27% of low-income survey respondents agreed.

Key Finding #2

When asked if they had access to enough healthy food to live an active healthy life, 70% of low-income survey respondents in Uniontown disagreed or strongly disagreed.

Key Finding #1:

Only 10% of low-income survey respondents (household income of \$49,00 less) thought Uniontown has sufficient opportunities for physical activity. So respondents recommended walking trail improvements and additional recommended.

We are hosting a grantee webinar on Thursday, June 15th at 1:30 PM. During this time, we will review expectations for regular updates, grant terms, timelines, the reporting process, and answer your questions. This webinar is required for all mural grantees.

You may begin your projects now with the matching funds you identified and have in place. You will not receive any grant funds until the full contract process has been completed. This process requires you to execute a contract with our agency and provide completed fiscal documents. This process can take up to several weeks from start to finish.

If your project involves a historical building, it will require a SHPO review. No grant funds will be dispersed until that review is completed and satisfactory. We will submit your project for SHPO review and they will have 30 days to review the project.

We will begin the contracting process this week. You will receive a Sexual Harassment policy and a W9 via DocuSign today. Please watch for this email directly from DocuSign (check spam/junk folders).

Additionally, attached to this email is an ACH form. If your organization would like to receive grant payments through an automatic deposit, complete the form and return it along with a copy of a voided check. If you do not wish to complete this step, you will receive payments via paper check sent in the mail.
