Re: Implementation of Electronic Reporting Rule – K.A.R. 28-15a-32

Under KAR 28-15a-32 (E-Reporting Rule) public water supply systems are required, upon written notification from the Kansas Department of Health and Environment (KDHE), to begin submitting documents, reports, surveys, assessments, monitoring and compliance data electronically. The regulation is listed below:

28-15a-32. Electronic reporting requirements. (a) No later than six months after written notification from the department, each person that operates a public water supply system shall meet the following requirements:

(1) Submit to the department a written acknowledgment of compliance with the electronic submission requirement; and

(2) commence the submission of all required documents, including surveys, assessments, reports, monitoring, and compliance data, by only electronic means.

(b) Each electronic submission shall be made according to the department's designated procedures. (Authorized by and implementing K.S.A. 65-171m; effective June 7, 2018.)

This letter serves as your written notification that beginning January 1, 2024, KDHE will begin phasing in e-reporting requirements. The KDHE will use two applications for e-reporting: 1) Public Water Supply Data Collector (PWSDC), and 2) Compliance Monitoring Data Portal (CMDP). The applications require a separate username and password for each individual that will submit data to KDHE. The PWSDC will be used for submission of assessments, surveys, certificates of delivery and public notices, Lead and Copper Rule Revisions (LCRR) service line inventories and certifications, public water supply contact changes, monthly operating reports, and others. The PWSDC is accessed through the Kansas Drinking Water Application Portal (Portal). The CMDP will be used for reporting private lab water quality data.

During calendar year 2024 KDHE will phase in e-reporting implementation according to the following tentative schedule:

Phase I:

Begin January 1, 2024

LCRR Service Line Inventories

Cyber Assessments

Revised Total Coliform Rule (RTCR) Level 1 Assessments

Public Water Supply Contact Changes

Phase II:

Begin April 1, 2024

Public Notification Rule Certificate of Delivery

Disinfectant and Disinfection Byproducts (DBP) Rule Operational Evaluation Level (OEL)

Consumer Confidence Reports

Phase III:

Begin July 1, 2024

Monthly Operating Reports (Surface Water Treatment Rule & Groundwater Rule)

Sample Site Plans: RTCR, LCRR, DBP Stage II

Begin CMDP private lab data beta testing

Phase IV:

Begin October 1, 2024

Complete CMDP Private lab data beta testing

Daily Chlorine Residual Logs

Every public water supply (PWS) system must have at least one and not more than 2 Portal accounts. Accounts are specific to an individual and may not be shared by multiple people at a PWS system. Please see the enclosed brochure for instructions on registering for a KDWAP account. Your Portal login will also be used to access Drinking Water Watch for your PWS system. For PWS systems using private labs, instructions for CMDP registration and login will be provided at a later date.

The registration deadline for a Portal account is December 1, 2023. After you have established your Portal username and password please login to the PWSDC and select the E-Reporting Acknowledgement Template to confirm that your PWS system will begin submitting information as requested by KDHE through the PWSDC to comply with KAR 28-15a-32.

Kansas Portal Account Access Using Old KEAP Username

Kansas Drinking Water Application Portal (Portal) Replaces KEAP

Each water system must have at least one and no more than two Portal contacts.

This contact will have access to:

- Drinking Water Watch to access information about your water system.

Applying For A New Portal Account

- Go to ks.gecsws.com or scan the QR code below and click on "New here? Register..."
- Enter the information requested, create a username, password and PIN. Choose Kansas Department of Health and Environment as the Agency and PWSDC as the Application and select Register.
- Monitor your email account for the confirmation of your submission.
 You must click the confirmation link in your email to complete the registration process.
- A KDHE employee will confirm your account and you will receive an email indicating your account was approved or denied.
