SOFTWARE LICENSE AGREEMENT

THIS AGREEMENT is entered into this	day or, 20	, by and between:

- A. Licensor has developed certain original, proprietary software and software support material referred to herein as the "Licensed Software" for use on personal computer systems including the Internet-based programming; and
- B. Licensee has requested a license to use the Licensed Software; and
- C. Licensor and Licensee desire to enter into an Agreement, whereby Licensee will obtain a license to use the product developed and supported by Licensor to be used for scheduling and staffing of personnel of Licensee.

THEREFORE THE PARTIES MUTUALLY AGREE AS FOLLOWS:

- 1. <u>License</u> Licensor grants Licensee a license to use the Licensed Software solely within the terms and conditions set forth herein. So long as Licensee does not breach any terms of this Agreement, Licensee may use the Licensed Software throughout the length of this Agreement. Licensee agrees that any breach of this Agreement may be grounds for immediate termination of this license.

- 4. - 5. <u>Defects and Enhancements</u> During the period of this Agreement, Licensor shall work with Licensee to correct any defects in the Licensed Software without additional charge. During this same period, Licensor will make available to Licensee, any enhancements it may make to the Licensed Software.
- 6. Warranties Licensee acknowledges that Licensor has made no express warranties with respect to the Licensed Software or any materials or information relating thereto. Licensee further understands and agrees that any liability from Licensor to Licensee shall be limited to actual damages, and Licensor shall not be liable to Licensee for any special, indirect or consequential damages of any kind arising in any manner from the Licensed Software or any materials or information relating thereto, or the use of the same. Licensee further acknowledges that Licensor has excluded from this Agreement all implied warranties and merchantability of fitness of the Licensed Software for a particular purpose.
- 7. <u>Confidentiality of Licensee Information</u> The information released by the Licensee in use of the software remains the property of the Licensee. Licensor agrees to provide secure hosting of the information, not to use the information for sales or marketing purposes, and not to divulge the information to any third person without the written consent of the Licensee.

The price may be subject to change with a thirty (30) day notification from Licensor to Licensee.
- 9. <u>Term and Termination</u> The Agreement shall begin on <u>TBD</u>, 2023, and shall continue from month to month thereafter unless terminated by either Licensor or Licensee by giving thirty (30) days notice to the other party. Within thirty (30) days after the termination of this Agreement, Licensee agrees to deliver to Licensor all manuals and materials related to the Licensed Software.
