Mr Heieck,

I wrote you late last spring with issues onboarding on the cloud. We went back to SimpleCity while they worked on our issues and onboarded again December 4, 2024.

We are having myriad issues with very little or no response from Support. We have purchased Finance and UB hubs. None of the utility billing payments are syncing with finance, so we can't reconcile the bank statement. We do manual meter readings. The software would not upload our meter readings; therefore we were unable to complete a billing run and print billing cards (we hand figured and wrote each billing card). We did not purchase PR hub as we felt it was not cost effective; however, when entering payroll in AP we cannot put in liabilities. This is the issue they have supposed to have been working on since May. Meter deposit was received after migration for a new account and we were unable to apply to Meter Deposits. Meter deposit interest did not figure correctly and figured three times, and we would like to apply the interest to the account, for all but a few accounts, on the December billing. We also apply meter deposits to the account of those customers that have had a year of on-time payments in December of each year. We also have final bill billing in December and unable to apply deposits and issue refund because we couldn't process the billing run. Also, can't find a guide for year-end procedures for UB.

We have received two emails to see if available for a call from support. We responded yes, but received no calls. I realize all of this is during the holiday season and year-end, but our issues are just as important as anyone elses.

We would like to go back to SimpleCity immediately in order to complete December processes and close out the year and begin the new year.

If gWorks is unable to meet with us to explain processes and resolve issues, a recommendation for finding a different vendor will be made to the council.
