**AMENDED CERTIFIED APPLICATION FOR EX PARTE TEMPORARY  
RESTRAINING ORDER**

Pursuant to K.S.A. 60-903

COMES NOW the Plaintiff, by and through counsel Jonathan L. Ehrlich, of KN Law Group, and upon the following amended statements and exhibits, respectfully asks the Court for a temporary restraining order instructing the Defendants, all sponsors or named circulators, and any other person, from circulating a Petition for Recall of Plaintiff from her office as Bourbon County Clerk. In support thereof, the Plaintiff offers the following:

(1) That K.S.A. 60-903 authorizes the Court to issue temporary restraining orders *ex parte*

when:

- a. Specific facts in an affidavit or a verified complaint clearly show that immediate and irreparable injury, loss or damage will result to the movant before the adverse party can be heard in opposition; *K.S.A. 60-903(a)(1)*;

- b. the movant's attorney certifies in writing any efforts made to give notice and the reasons why it should not be required, *K.S.A. 60-903(a)(2)*; and
  - c. *[N]otice of the issuance of a temporary restraining order is provided...to the appropriate city clerk or county clerk if the adverse party is a city or county or an agency, officer or employee thereof. K.S.A. 60-903(a)(3).*
- (2) That on May 22, 2026, Plaintiff filed a Verified Petition for Declaratory Judgment and Injunctive Relief, which clearly alleges through statements of fact and supporting documents that:
- a. A recall petition is being circulated seeking signatures to recall Bourbon County Clerk Susan E. Walker;
  - b. The recall petition was not determined sufficient by the Bourbon County Attorney as required by *K.S.A. 25-4322(b)*; and
  - c. The recall petition being circulated is invalid.
- (3) That as a result of the invalid recall petition being circulated, the press and public are engaged in substantial and frequent discourse about a possible recall election that will not occur if this Court grants Plaintiff's Petition. TRO Exhibit A.
- (4) That the public's discourse spurred by the invalid recall petition being circulated undermines confidence in Plaintiff and all elected officials.
- (5) That Plaintiff is being personally and professionally targeted as a result of the invalid recall petition being circulated. *See TRO Exhibits B-F.*
- (6) *That members of the public are photographing Plaintiff and her family to post online with untrue claims. See TRO Exhibits D & F.*
- (7) That the circulation of the invalid recall petition causes irreparable harm to the Plaintiff's personal and professional reputation. *See TRO Exhibits A-F.*

- (8) *That the circulation of the invalid recall petition causes continuing irreparable harm to the Plaintiff's ability to perform her duties as Bourbon County Clerk. See TRO Exhibit F.*
- (9) That if the invalid recall petition acquires sufficient signatures, it may be presented for certification and election causing Plaintiff to wrongfully lose her position as Bourbon County Clerk.
- (10) *That on May 26, 2026, Plaintiff's counsel contacted all named defendants inquiring about setting a hearing on Plaintiff's Application for Temporary Restraining Order and received the following responses:*
- a. *Defendant Crux – Plaintiff's counsel emailed Defendant Crux and, at his request, included Bourbon County Counselor Bob Johnson. The email notified Defendant Crux the Court rejected Plaintiff's request for an ex parte TRO and asked if Defendant Crux is available later this week for a hearing. Bob Johnson replied, "I sent this to Kcamp for coverage under our insurance." Plaintiff's counsel responded, "Thank you for the update. I will keep an eye out for an EOA. Of course, counsel may call me anytime..." As of this filing, Plaintiff's counsel has not received an entry of appearance or a phone call from counsel for Defendant Crux.*
  - b. *Defendant Recall Committee (Kyle Parks). On May 26, 2026, Plaintiff's counsel called Mr. Parks but the call was not answered. Plaintiff's counsel left a voicemail asking for a callback from Parks or his attorney to discuss setting a hearing on Plaintiff's Application for Temporary Custody Order. As of filing, Plaintiff's counsel has not received a call back from Mr. Parks or his attorney.*
  - c. *Defendant Recall Committee (Kevin Wagner) – On May 26, 2026, Plaintiff's counsel called Mr. Wagner and asked if he had counsel or was willing to speak to*

*Plaintiff's counsel without counsel about asking the Court for a hearing on the Application for Temporary Restraining Order. Mr. Wagner responded, "I don't know." Plaintiff's counsel asked again if Mr. Wagner had counsel. Mr. Wagner replied, "Is that any of your business? I don't think it is" and hung up.*

d. *Defendant Recall Committee (Lyle Owenby) – Plaintiff's counsel called and spoke to Mr. Owenby asking if Mr. Owenby had counsel. Mr. Owenby said he had spoken to someone but has not hired an attorney yet. Plaintiff's counsel asked if Mr. Owenby was willing to speak with him about asking the Court for a hearing this week to argue Plaintiff's Application for a Temporary Restraining Order. Mr. Owenby said he would like to speak to an attorney first, and asked Plaintiff's counsel to call him back [approximately two hours later]". Plaintiff's counsel called Mr. Owenby back after a couple hours. Mr. Owenby informed Plaintiff's counsel he had spoken to an attorney and intended to hire him. The call ended.*

(11) *That Plaintiff and her office will continue to experience and sustain irreparable harms so long as the Recall Petition circulates.*

(12) *That Defendants' responses to this application should not be required prior to the Court issuing a temporary restraining order because the recall petition being circulated is clearly invalid, irreparable harm will continue and escalate if a TRO is not granted, and Defendants do not appear able to respond to the Petition promptly.*

WHEREFORE, the Plaintiff respectfully asks this Court to issue a temporary restraining order *instructing* the Defendants, the named petition circulators, and any other person, to cease circulating the Petition to Recall Plaintiff.

# Bourbon County Clerk facing recall after ballot mistakes, possible intimidation attempts

Some Bourbon County residents say they are concerned by what they perceive as intimidation efforts by Bourbon County Clerk Susan Walker, a Republican, related to an attempt to force a recall election

In a recent press release in response to the ["vote of no confidence"](#) by the Bourbon County GOP, and the certification of a recall petition against Walker by Bourbon County Attorney James Crux, Walker listed the names of three people who are sponsors of the petition, when and if they voted in the November 2025 election, and of five people carrying the petition who did not vote at all in the election.

Walker is both the chief election officer and chief records custodian of Bourbon County. She claimed in her [release](#) to have filed a request under the Kansas Open Records Act for the information.

"I completed a KORA request on the Sponsors and Circulators of Voting History to see if they voted during the General Election in 2025," Walker said in the release.

However, she declined to answer how those names and voting records were relevant to the petition. Walker, as chief election officer, would presumably have access to those records without a KORA request. As chief records custodian, she is the person to whom a similar request would normally be addressed.

*The Sentinel* asked why she felt it necessary to file a KORA request for data she should have access to and to whom it was addressed. Walker declined to answer those questions as well.

Further, Walker admitted in a recent email that she had an attorney send a "cease-and-desist" letter to a Bourbon County resident, accusing them of defaming her.

"This is a legal matter and does not concern this particular situation regarding the election," Walker wrote, while asking for more time to answer an initial series of questions about her conduct posed by *The Sentinel*. The cease-and-desist letter was written as a result of the individual falsely accusing me of a crime in an effort to defame me."

Mr. Richardson,

I am not sure I will be able to meet your noon deadline today as I have training and a meeting and I want to be sure to represent all of the facts.

*The Sentinel* then asked Walker to provide evidence of defamatory conduct by the resident or provide the letter in question. Walker promised to send the resident's Facebook statement, which prompted the letter, but never did so.

*The Sentinel* pressed further about any evidence of defamatory conduct toward Walker. She declined to comment.

## Mistakes in Uniontown school board race prompt Bourbon County recall

Walker is facing a potential recall less than two years after she was elected — running unopposed — following [ballot errors](#) in the November general election.

The action stems from the Uniontown USD 235 school board race, when Walker's office — by her own admission — printed ballots which omitted the names of the school board candidates during early voting. Correct ballots were eventually printed — the night before the election — and delivered to polling places.

One source, speaking on condition of anonymity for fear of retaliation by Walker, said some of the ballots weren't delivered to some polling places until 8 a.m. — an hour after voting began and far less than the 12 hours required by law.

In a [release](#), Walker blamed the district, stating that districts are, by law, required to run their elections by selecting a "voting plan."

"Voting plan C was used to build the ballots for early voting, which only listed precinct nominations," the release said. "Voting plan B should have been used, which would include all USD 235 seats for residents to cast their vote."

Walker, in two separate releases, has blamed the district for the error in the ballot that disenfranchised 52 early voters. While it is possible the district did, indeed, make the mistake, as the chief election officer, it is Walker's duty to ensure the ballots are correct. *The Sentinel* asked Walker to cite the statute that would require the district — rather than the county election officer — to [ensure the ballots are correct](#). She declined to comment.

The voting errors — among other issues — caused the Bourbon County Republican Party to [issue a vote of no-confidence](#) against Walker.

The letter sent to Walker by the local party placed the blame for the errors on Walker.

"Your office attributed the error to the school district for allegedly filing the wrong plan, rather than accepting responsibility for the inaccurate preparation, proofreading, and verification of ballots as required by Kansas election statutes," the letter reads. "The County Clerk, as the chief election officer, bears the ultimate responsibility for ensuring that ballots accurately reflect all properly filed candidacies in accordance with state law and the Kansas Election Standards."

The Bourbon County GOP also castigated Walker for interfering with other elected officials.

"Furthermore, the precinct committeemen and committeewomen believe that your actions regarding attempts to influence other elected offices and positions lack integrity, further eroding public confidence in the impartial administration of county government," the GOP wrote. "This incident, along with the broader concerns noted above, undermined public trust in the integrity and accuracy of the electoral process and county operations in Bourbon County."

## County attorney certifies petition

According to the [Bourbon County Monitor](#), Crux certified the petition as correct in form on April 27, triggering a 90-day window to collect the needed signatures to force an election.

Under K.S.A. 25-4325, petition organizers need signatures equal to 40% of the total votes cast for all candidates for that office in the last general election. They have until July 26.

According to the *Monitor*, Crux told Bourbon County Commissioners that it would be 2,374.

A source tells *The Sentinel* more than 2,200 signatures have already been collected.

By statute, because Walker is the subject of the recall, Crux — also a Republican — will certify the signatures to avoid conflicts of interest.

#### Statement from the Chair of the Bourbon County Republican Party:

Here are my key concerns:

- **Potentially Inaccurate and Selective Use of Voter Records:** While voter data is public under the Kansas Open Records Act (KORA), its selective and targeted release against political critics—especially when some named individuals have stated they did vote—suggests retaliatory intent, raises questions about record accuracy, and crosses a line into intimidation. Publicly using potentially inaccurate data to shame opponents creates a chilling effect on citizens exercising their recall rights and undermines transparent, impartial government.
- **Retaliatory Pattern and Intimidating Effect:** This action appears to fit a broader pattern. Many of the affected individuals are Republican Precinct Committee persons who participated in appointing new county commissioners after two prior commissioners resigned amid rising conflicts within the courthouse. These same individuals also supported the Bourbon County Republican Party's Vote of No Confidence in her. Multiple residents and potential candidates have expressed hesitation to run for office or speak publicly due to fears of retaliation, including reported cease-and-desist letters sent over social media comments.
- **Undermining Public Trust in Elections:** As the official responsible for conducting fair and

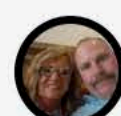

## **AFFIDAVIT OF SUSAN E. WALKER**

STATE OF KANSAS

COUNTY OF BOURBON

I, Susan E. Walker, being first duly sworn upon oath, state as follows:

1. My name is Susan E. Walker. I am competent to testify to the matters contained herein, and make this affidavit based upon my personal knowledge.
2. I currently serve as the duly elected Bourbon County Clerk & Election Officer for Bourbon County Clerk's Office and have held this position since January 2025
3. As Bourbon County Clerk, my responsibilities include maintaining county records, administering elections, managing official county business, financial oversight, and ensuring the efficient operation of the Clerk's Office for the citizens of Bourbon County.
4. A recall petition has recently been circulated within Bourbon County concerning a ballot error that took place during the General Election on November 4, 2025.
5. Since the circulation of this petition, I have experienced substantial disruption to my ability to effectively perform my official duties.
6. Specifically, the circulation of the petition has negatively affected the operations of the Clerk's Office in the following ways:
  - Increased interruptions to daily office operations;
  - Excessive phone calls and complaints due to misinformation being circulated via social media;
  - Diversion of staff time and county resources away from official duties;
  - Difficulty maintaining an efficient and professional work environment;
  - Citizens stating I accosted an individual while signing up for an elected position.
  - Citizens stating on social media I am intimidating others not to run and that I would retaliate against those who sign the petition by increasing their taxes – which is a function I do not handle.
7. The circulation of the petition has also caused harm to my personal and professional reputation within the community.

- Unsolicited pictures circulating of my family after work hours while pumping fuel and purchasing a pizza at a local gas station.
  - Circulators are not sticking to the intent of the petition and going beyond what the spirit of the petition is truly about.
  - Circulators are stating on social media I have stolen from the county and committing crimes and the public responds as if they believe the statements.
  - Citizens are stating I am violating the SLAPP laws.
  - Circulators are stating I am following them around town where they are gathering signatures to intimidate holders and signers.
    1. Residents are asking if they are fearing for their safety or being stalked.
  - A circulator contacted the media from Crawford County and said I was retaliating because of the petition.
  - Social media posts are accusing me of being vindictive, wasting courts time, and filing frivolous wasteful lawsuits.
  - Social media posts stating I am greedy and toxic.
  - Social media posts stating taxpayers cannot be in the courthouse at the same time or attend county meetings if I am there.
  - Circulator stating that Dennis Fry was not on the November ballot and that I said he wasn't running and that her vote was thrown out. This is not a true statement.
  - Circulator stated that I said that 52 votes did not matter. This is not a true statement.
8. I have become aware of statements and accusations associated with the petition that have resulted in public criticism, hostility, and damage to the public's confidence in my office and my ability to carry out my responsibilities.
9. As a result of these events, I have experienced stress, distraction, and interference with my ability to perform the duties entrusted to me as Bourbon County Clerk.
10. The continued circulation of the petition and related conduct threatens to further impair the effective operation of the Clerk's Office and the delivery of services to the residents of Bourbon County.
